SHOW RULES and REGULATIONS

Setup Hours: from 7:00 a.m. to 9:00 a.m.
Tear-down from 4:00 p.m. to 5:00 p.m.

A deposit of **50%** per participant dealer is due with the booking. Cheques must be made out to **Polish-Canadian Coin & Stamp Club**. Balance must be paid in full on the day of show. The deposit is non-refundable.

Booth Specifications - Each booth includes number of tables purchased by the dealer (eight foot tables); up to 5 chairs (for front & back of tables) and a back table (size based on availability).

Setup and Tear-down - The facilities will be available to the dealers from 7:00 a.m. on the morning of the show for set-up. Set-up must be completed by 9 a.m.

Tear-down CANNOT start before end of show at 4 p.m.

Dealers are responsible for transporting and securing their own merchandize and materials.

General Conditions - Tables will be assigned in order of received deposits. The Dealer agrees that the booth space will be used exclusively by him/her and in no case will be transferred, shared or used by any other person(s) or organization(s) unless prior agreement has been established with the show organizer. No dealer shall add additional tables to their booth without the express consent of the show organizer. All sales shall be limited solely to the contracted booth space. Terms of rental are solely for the area encompassed within the tables provided. Any participant displaying materials outside of these boundaries is subject to removal from the show.

The Dealer agrees to display provided Dealer Name tags at all times. Booths must be staffed at all times during show hours. Dealers who leave their booths unattended do so at their own risk and assume full responsibility for their materials.

Breach of Contract - Participant agrees with the rules and regulations of the show. The participant dealer understands that any breach of this contract may result in expulsion from this and no participation in the future shows.

Insurance and Liability

Participants are urged, in their own interest, to arrange for insurance of their merchandise. The organizers (Polish Canadian Coin & Stamp Club "Troyak") or the John Paul II Polish Cultural Centre or the Show Sponsors and their directors, officers, members, employees, voluntary or paid staff, agents or delegates assume no responsibility whatsoever, whether as the result of negligence or otherwise, for any loss of or damage to dealers' merchandize or other property arising from any cause whatsoever.
